ORDINANCE
COMMUNITY SAVINGS BANK Acct. No. 7354
- 1 Permit No. 1110507

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to COMMUNITY SAVINGS BANK, upon the terms and subject to the conditions of this ordinance to maintain and use three.(3) sign(s) projecting over the public right-of-way attached to its premises known as 4801 W. Belmont Ave..

Said sign structure(s) measures as follows; along W. Belmont Avenue:

One (1) at nine (9) feet in length, sixteen point zero eight (16.08) feet in height and ten point one seven (10.17) feet above grade level.

One (1) at three (3) feet in length, four (4) feet in height and nine point one seven (9.17) feet above grade level.

Said sign structure(s) measures as follows; along N. Cicero Avenue:

One (1) at nine (9) feet in length, sixteen point zero eight (16.08) feet in height and eleven point nine two (11.92) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1110507 herein granted the sum of seven hundred (\$700.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after 12/17/2013. Ray Suarez 31st Ward
