### ORDINANCE

#### **BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:**

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit District, as shown on Map 5-J in the area bounded by:

**West Wabansia Avenue, the public alley east of and parallel to North Central Park Avenue, a line 50 feet South of and parallel to West Wabansia Avenue, North Central Park Avenue.**

**To those of RM-5 Residential Multi-Family District.**

SECTION 2. This ordinance takes effect after its passage and approval.

In compliance with the "Type 1" rezonings requirements, the following Narrative is provided concerning the application to change zoning for 1653-55 North Central Park Avenue/3565-3575 West Wabansia Avenue, Chicago, Illinois from RS-3 to RM-5:
