Be It Ordained by the City Council of the City of Chicago;

SECTION 1. Permission and authority are hereby given; and granted to THALIA HALL, upon the terms and subject to

the conditions of this ordinance to maintain and use, as now constructed, six (6) Fire Escape(s) projectingi.over the

public right-of-way adjacent to its premises known as 180.7 S. Allport St..

One (1) at twenty-seven point eight three (27.83) feet inlength, and three point eight three (3.83) feet in width ifor a total of one hundred six point five nine (106.59) square feet.

One (1) at five point eight three (5.83) feet in length, and three point eight three (3.83) feet in width for a total of twenty-two point three three (22.33) square feet.

One (1) at seventy-two (72) feet in length, and three point eight three (3.83) feet in width for a total of two hundred seventy-five point seven six (275.76) square feet.

Said Fire Escape(s) at 1215-17 W. 18th Street measure(s):

One (1) at eight (8) feet in length, and three point eight three (3.83) feet in width for a total of thirty point six four (30.64) square feet.

One (1) at forty (40) feet in length, and three point eight three (3.83) feet in width for a total of one hundred fifty-three point two (153.2) square feet.

One (1) at forty-two (42) feet in length, and three point eight three (3.83) feet in width for a total of one hundred sixty point eight six (160.86) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1110593 herein granted the sum of two thousand four hundred (\$2,400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property causedJayTFie City performing work in the public way.
