Said sign structure(s) measures as follows; along N Southport Ave:

One (1) at one (1) foot in length, one point six seven (1.67) feet in height and thirteen point one seven (13.17) feet above grade level.

One (1) at one point five (1.5) feet in length, two point five (2.5) feet in height and eleven (11) feet above grade level.

One (1) at one point six seven (1.67) feet in length, eleven (11) feet in height and fourteen point three three (14.33) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10 -28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1111376 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.
