ORDINANCE
UNIVERSITY OF CHICAGO MEDICAL CENTER Acct. No.
6533- 14 Permit No. 1112337

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UNIVERSITY OF CHICAGO MEDICAL CENTER, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Canopy (s) projecting over the public right-of-way adjacent to its premises known as 5700 S. Maryland Ave..

Said Canopy(s) at E. 57th St measure(s):

One (1) at one hundred seventy-four point nine one (174.91) feet in length, and four point five (4.5) feet in width for a total of seven hundred eighty-seven point one (787.1) square feet.

Said Canopy(s) at E. 57th St measure(s):

One (1) at one hundred sixty-five point eight three (165.83) feet in length, and four point five (4.5) feet in width for a total of seven hundred forty-six point two four (746.24) square feet.

Said Canopy(s) at S. Cottage Grove measure(s):

One (1) at forty-five point five (45.5) feet in length, and one point five (1.5) foot in width for a total of sixty-eight point two five (68.25) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1112337 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
