A line 131.84 feet east of and parallel to South Emerald Avenue; then west 31.84 feet along the alley next south of 115th Street; then 100.00 feet south of and parallel to the public alley; South Emerald Avenue; and West 115th Street,

to those of a CI-1 Community Commercial District and corresponding use district is hereby established in the area above described.
