### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 District symbols and indication as shown on Map No. 3-H in the area bounded by:

North Milwaukee Avenue; a northeasterly perpendicular line to North Milwaukee Avenue 277.20 feet southeast of the southeast boundary line of North Wood Street (as measured along the northeast boundary line of North Milwaukee Avenue); the public alley next northeast of and parallel to North Milwaukee Avenue; a northeasterly perpendicular line to North Milwaukee Avenue 325.20 feet southeast of the southeast boundary line of North Wood Street (as measured along the northeast boundary line of North Milwaukee Avenue),

to those of B3-2 District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance takes effect after its passage and approval.

**Proposed Use of Property**

The building located at 1365-67 N. Milwaukee Ave. is the proposed site for two restaurant developments. These developments will require a rezoning to B3-2 from B1-2 to allow the restaurants to have incidental liquor service, a shared kitchen, and a Special Use permit for a rooftop patio. A proposal for this project was voted on and supported by the P&D Committee and the WPC membership, with the caveat that no occupants or furnishings will be visible on the roof from the street.

As this building is located within the Milwaukee Avenue Landmark District, the Landmarks Commission will be involved with its restoration. The Property is approximately 5,000 square feet. The height of the front facade will be 19 feet and the total height of the building to be 27 feet. As previously stated, for efficiency and cost effectiveness, Christopher Johnston (owner and operator of both restaurants) desires that both restaurants share a kitchen. Finally, customer parking for both restaurants will be street parking only.

The specifics of each proposed restaurant are as follows:

The restaurant located 1365 N. Milwaukee will be DBA Cheesie's Pub & Grub ("Cheesie's"). Cheesie's is a restaurant that primarily features grilled cheese sandwiches, with additional locations in Chicago, Illinois at 958

W. Belmont Ave., and Evanston, Illinois at 622 Davis St. In addition, this Cheesie's location will be seeking to offer patrons full bar service. Christopher Johnston is the majority owner and the operator of Cheesie's, and the hours of operation will comport with all local ordinances.

The restaurant located at 1367 N. Milwaukee will be DBA Whiskey Business Fry Bar ("WB"). This is a new concept, created by owner Christopher Johnston, focusing on a large French-fry and stuffed burger menu with a 1980's and 1990's theme. This business will have an indoor dining area and a rooftop patio for outdoor dining. Christopher Johnston is the majority owner and the operator of WB's, and the hours of operation will comport with all local ordinances.
