ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 3-1 in the area bounded by:

West Haddon Avenue; a line 96 feet East of and parallel to North Rockwell Street; the public alley next south of and parallel to West Haddon Avenue; a line 72 feet East of and parallel to North Rockwell Street.

To those of an RT3.5 Residential Two-Flat, Townhouse and Multi-Unit Zoning District SECTION 2.
