ORDINANCE
UNIVERSITY OF CHICAGO Acct. No.
43697-120 Permit No. 1112318

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to UNIVERSITY OF CHICAGO, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Caisson(s) under the public right-of-way adjacent to its premises known as 5500 S. University Ave.. Said Caisson(s) at S. University Avenue measure(s):

Two (2) at eleven point five (11.5) feet in length, and two point three three (2.33) feet in width for a total of fifty-three point five nine (53.59) square feet. Said caissons shall be approximately thirty-two (32) feet below grade level.

One (1) at eight (8) feet in length, and point five eight (.58) feet in width for a total of four point six four (4.64) square feet. Said caisson shall be approximately thirty-two (32) feet below grade level.

One (1) at six point five (6.5) feet in length, and point three three (.33) feet in width for a total of two point one five (2.15) square feet. Said caisson shall be approximately thirty-two (32) feet below grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1112318 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
