ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the current Residential Planned Development No. 1078 symbols and indications as shown on Map No. 4-G in the area bounded by:

West 15th Street; South Loomis Street; the alley next south of West 15th Street; and South Laflin Street to those of a B2-3 Neighborhood Mixed-Use District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.
