ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 26-1 in area bound by

The alley next West and parallel to South Western Avenue, a line 188.20 feet South of and parallel to 106th Street, South Western Avenue, a line 248.20 feet South of and parallel to 106th Street.

to those of a C1-1 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.
