ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION I. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the M1-2 Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 1-G in the area bound by

a line 50.5 feet north of and parallel to West Ohio Street; North May Street; a line 25.5 feet north of and parallel to West Ohio Street; and the alley next west of and parallel to North May Street

to those of a RM5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

Proposed Zoning: RM5 Residential Multi-Unit District Lot Area: 116'

x 25' totaling 2,900 sq. ft.

The applicant seeks a zoning change to permit a new three dwelling unit building with on-site parking for three vehicles. There will be no commercial space, and the building will be 44'-4" in height.
