ORDINANCE GCYC, LLC Acct. No. 328191 -1 Permit No. 1114703

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to GCYC, LLC, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Building Projection over the public right-of-way adjacent to its premises known as 7208 S. Ingleside Ave..

Said Building Projection(s) at S. INGLESIDE AVE measure(s):

One (1) at forty-four (44) feet in length, and five (5) feet in width for a total of two hundred twenty (220) square feet. Existing building projection is approximately twenty-four (24) feet six (6) inches above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1114703 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
