### ORDINANCE

***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B3-2 Community Shopping District symbols and indications as shown on Map No. 17-N in the area bound by

West Touhy Avenue; a line perpendicular to West Touhy Avenue lying 173.31 feet east of North Caldwell Avenue as measured along the southern right-of-way of West Touhy Avenue ; a line 112 feet south of and parallel to West Touhy Avenue; and North Caldwell Avenue

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
