BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, Section 160, of the Municipal Code of Chicago, the following locations are hereby designated as Loading Zones for the distances specified, during the hours specified:

| 27 | 201-209 N. Green Street; N. Green Street (east side) from a point 20 feet north of W. Lake Street to a point 40 feet north thereof; No Parking Loading Zone, 6:00am to 3:00am, all days -- (14-01314362) [02014-5061] |

Racine Avenue to a point 25 feet east thereof; No Parking Loading Zone, distance of 25 feet, 5:00pm to 10:00pm, Monday through Friday, 11:00am to 10:00pm, Saturday, and 11:00am to 6:00pm, Sunday, by striking the above and inserting in lieu thereof: W. Armitage Avenue (south side) from a point 283 feet east of N. Racine Avenue to a point 32 feet east thereof; No Parking Loading Zone, distance of 32 feet, 5:00pm to 10:00pm, Monday through Friday, and 11:00am to 10:00pm, Saturday and Sunday [02014-8914] |
