ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-1, Limited Manufacturing/Business Park District symbols and indications as shown on Map No. 11 -K in the area bounded by

West Montrose Avenue; the public alley next east of and parallel to Cicero Avenue; the public alley next south of and parallel to West Montrose Avenue; and a diagonal line commencing 56.90 feet east of the public alley next east of and parallel to Cicero Avenue and extending southeasterly and ending at a point 100.73 feet east of the public alley next east of and parallel to Cicero Avenue,

to those of a C2-3 Motor Vehicle-Related Commercial District. SECTION 2. This ordinance

takes effect after its passage and approval.303

The subject property (site), located at 4739 West Montrose Avenue, in Chicago, Cook County, Illinois, consists of a parcel of land located on the south side of West Montrose Avenue, approximately 175' east of North Cicero Avenue. The site is bound by an existing $\pm 16'$ alley (North Kilpatrick Avenue) to the south, an existing $\pm 16'$ alley to the west and existing elevated railroad tracks to the east. The site is currently occupied by an existing one-story brick building approximately 8,975-SF in size.
