ORDINANCE ARMOUR & SWIFT Acct. No. 393813-1 Permit No. 1115378

Be It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to ARMOUR & SWIFT, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use six (6) Awning(s) projecting over the public right-of-way adjacent to its premises known as 1000 W. Fulton Market.

Said Awning(s) at N. Morgan Street measure(s):

Two (2) at fifteen point eight three (15.83) feet in length, and five (5) feet in width for a total of one hundred fifty-eight point three (158.3) square feet.

One (1) at fourteen point three three (14.33) feet in length, and five (5) feet in width for a total of seventy-one point six five (71.65) square feet.

One (1) at fourteen point five eight (14.58) feet in length, and five (5) feet in width for a total of seventy-two point nine (72.9) square feet.

Said Awning(s) at W. Fulton Market measure(s):

Two (2) at fifteen point four two (15.42) feet in length, and five (5) feet in width for a total of one hundred fifty-four point two (154.2) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1115378 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
