ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Cl-2, Neighborhood Commercial District symbols and indications as shown on Map No. 5-H in area bound by

The South right-of-way of West Medill Street; a line from a point 61 feet East ofNorth Leavitt Street and the South right-of-way line of West Medill Street, to a point, 24 feet South of the South right-of-way of West Medill Street if extended and 93 feet East ofNorth Leavitt Street; a line 24 feet South of the South right-of-way line of West Medill Street if extended; and North Leavitt Street,

to those of a C 1-3 Neighborhood Commercial District.

SECTION 2. This ordinance takes effect after its passage and approval.
