ORDINANCE PMG LS INVESTMENTS, LLC Acct. No. 396007 -1 Permit No. 1116703

Se It Ordained by the City Council ofthe City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to PMG LS INVESTMENTS, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use sixteen (16) Caisson(s) under the public right-of-way adjacent to its premises known as 2201-2231 N. Milwaukee Ave..

Said Caisson(s) at N. Milwaukee Avenue measure(s):

Fourteen (14) atone (1) foot in length, and one point seven five (1.75) foot in width for a total of twenty-four point five (24.5) square feet. Said caissons shall be approximately forty-three (43) feet below grade level.

Said Caisson(s) at N. Talman Avenue measure(s):

Two (2) at one (1) foot in length, and one point seven five (1.75) foot in width for a total of three point five (3.5) square feet. Said caissons shall be approximately forty-three (43) feet below grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1116703 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way. Proco Joe Moreno 1 st Ward Page 1
