ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance,

is hereby amended by changing all the Cl-1 Neighborhood Commercial District and Ml-1

Limited Manufacturing/Business Park District symbols and indications as shown on Map

No.3-K in the area bounded by

West North Avenue; a line 73 feet east of and parallel to North Cicero Avenue; the alley next south of and parallel to West North Avenue; and North Cicero Avenue,

to those of a Cl-1 Neighborhood Commercial District and a corresponding uses

district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

NARRATIVE

The address of the parcel is 4759 West North Avenue and 1555 North Cicero Avenue. The current zoning of the parcel is C1-1 Neighborhood Commercial District and M1-1 Limited

Manufacturing/Business Park District. The zoning amendment is required to change the zoning of the parcel to C1-1 Neighborhood Commercial District. The zoning change is needed to allow the existing two-story building to have additional retail stores and maintain the existing dwelling units above. The commercial square footage is 6,400 square feet.

The lot size is 8,906 square feet (73 square feet x 122 square feet.). The minimum lot area per dwelling unit is 1,484 square feet. The Existing floor area is 12,918 square feet. The floor area ratio is 1.45. The south front setback is zero (-0-). The north rear setback is zero (-0-). The east and west side setback is zero (-0-). There are five (5) parking spaces.

After rezoning all the property will be used for retail use, six existing dwelling units, five parking spaces, commercial space of 6,400 square feet and building height of 26.7 feet.
