#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Community Shopping District., as shown on Map 7-1 in the area bounded by:

North Elston Avenue, a line 81.26 feet Northwest of West Barry Avenue, the alley southwest and parallel to North Elston Avenue and a line 106.26 feet Northwest of West Barry Avenue.

To those of B2-3 Neighborhood Mixed-Use District

SECTION 2. This ordinance takes effect after its passage and approval.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about April 28, 2015, the undersigned will file an application for a change in zoning from B3-1 Community Shopping District to B2-3 Neighborhood Mixed-Use District for the property located at 3138

North Elston Avenue, Chicago, Illinois.

This zoning change is needed to allow for the conversion of the front building, 1<sup>st</sup> floor commercial space to be used as a third dwelling unit. The existing rear coach house will remain one dwelling unit (for a total of four dwelling units). The existing building height is 31 feet high. The footprint of the building will not change. No parking will be provided.
