ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3, Residential Single-Unit (Detached House) District, as shown on Map 1-G in the area bounded by:

West Superior Street, a line 152.27 feet West of North Armour Street, the alley south and parallel to West Superior Street and a point 177.31 feet west of North Armour Street.

To those of RM-4.5, Residential Multi-Unit District

SECTION 2. This ordinance takes effect after its passage and approval.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about April 28, 2015, the undersigned will file an application for a change in zoning from RS-3, Residential Single-Unit (Detached House) District to RM-4.5, Residential Multi-Unit District for the property located at 1517 West Superior, Chicago, Illinois.
