ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the Bl-1, Neighborhood Shopping District symbols and indications as shown on Map No. 3-1 in area bound by

A line 100 feet west of and parallel to North Artesian Avenue, the alley next north and parallel to West Division Street, a line 75 feet west of and parallel to North Artesian Avenue, West Division Street

to those of a Bl-2, Neighborhood Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.
