### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the CI-2, Neighborhood Commercial District, as shown on Map 4-H in the area bounded by:

**West Cullerton Street, a line 100 feet West of South Wolcott Avenue, the alley South and parallel to West Cullerton Street and a line 150 feet West of South Wolcott Avenue.**

To those of B2-2, Neighborhood Mixed-Use District

SECTION 2. This ordinance takes effect after its passage and approval.
