BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1 That the City Zoning Ordinance be amended by changing all the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 5-1 in area bound by

WEST BELDEN AVENUE; A LINE 62 FEET EAST OF AND PARALLEL TO NORTH WASHTENAW AVENUE; WEST LYNDAL STREET; AND NORTH WASHTENAW AVENUE

To those of an RT-4 Residential Two-Flat, Townhouse and Multi-Unit District, and a corresponding use district is hereby established in the area above described.

SECTION 2 The ordinance shall be in force and effect from and after its passage and due publication.
