BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-5 Neighborhood Shopping District symbols and indications as shown on Map No. 9-F in area bound by

North Broadway Avenue, a line perpendicular to North Broadway and 104 feet north of the intersection of north Broadway and West Grace, the alley next east of and parallel to north Broadway Avenue, West Grace Street

to those of a B3-5 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and approval.
