COMMERCIAL ORDINANCE

WHEREAS, the City of Chicago ("City") is a home rule unit of local government pursuant to Article VII, Section 6 (a) of the 1970 constitution of the State of Illinois and, as such, may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the properties located at 2235-39 W. 35th Street are owned by 2235-39 W. 35th Street, LLC, an Illinois limited liability company; and the properties located at 2241-2245 W. 35th Street are owned by Gilberto Zavala and Ana Zavala, (cumulatively and subsequently known as "The Adjacent Owners"; and

WHEREAS, The Adjacent Owners propose to use the portion of the alley to be vacated herein for extended playground and recreational space for the adjacent Montessori School; and homeowners respectively; and

WHEREAS, the City Council of the City of Chicago, after due investigation and consideration, has determined that the nature and extent ofthe public use and the public interest to be subserved is such as to warrant the vacation of part of public alley, described in the following ordinance; now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. LEGAL DESCRIPTION: THAT PART OF THE 16 FOOT WIDE PUBLIC ALLEY LYING SOUTH OF AND ADJOINING THE SOUTH LINE OF LOTS 1, 2, 3, 4, AND 5; LYING WEST OF AND ADJOINING THE WEST RIGHT OF WAY LINE OF S. BELL AVENUE (FORMALLY KNOWN AS S. IRVING AVENUE); LYING EAST OF AND ADJOINING THE SOUTHERLY EXTENSION OF THE WEST LINE OF LOT 5; AND LYING NORTH OF AND ADJOINING THAT PART OF THE NORTHERLY LINES OF LOT 23, ALL INCLUSIVE, IN WESTON'S SUBDIVISION OF BLOCK 2 IN J.H. REE'S SUBDIVISION OF THE NORTHWEST 1/4, OF THE SOUTHWEST 1/4 OF SECTION 31, TOWNSHIP 39 NORTH, RANGE 14 EAST OF THE THIRD PRINCIPAL MERIDIAN, AS RECORDED FEBURARY 18, 1876 AS DOCUMENT NUMBER 72840, IN COOK COUNTY, ILLINOIS, CONTAINING 1953.1 SQ. FT., 0.45 ACRE, MORE OR LESS as shaded and legally described by the words "HEREBY VACATED" on the plat hereto attached as Exhibit A, which drawing for greater clarity, is hereby made a part of this ordinance, be and the same is hereby vacated and closed, inasmuch as the same is no longer required for public use and the public interest will be

subserved by such vacation.

SECTION 2. The City of Chicago hereby reserves for the benefit of Commonwealth .Edison.j AT&T/SBC, Comcast and their successors or assigns, a non-exclusive utility easement to operate, maintain, construct, replace and renew overhead wires, poles, and associated equipment and underground conduit, cables, and associated equipment for the transmission and distribution of electrical energy, telephonic and associated services-under, over and along the alley herein vacated, with the right of ingress and egress. The grade of the vacated public way shall not be. altered in a manner'so as to interfere with the operation and maintenance of Commonwealth Edison, ComCast and/or AT&T/SBC facilities. No buildings, permanent structures or obstructions shall be placed over Commonwealth Edison,: ComCast and/or AT&T/SBC facilities without express written release of easement by the aforementioned involved utility. Any future vacation-beneficiary prompted relocation of Commonwealth Edison, ComCast and/or AT&T/SBC facilities lying within; the area being vacated will be accomplished by Commonwealth Edison, ComCast and/or AT&T/SBC, and done at the expense of beneficiary of the vacation.

SECTION 3. The vacation herein provided for is made upon the express condition that within 180 days after the passage, of this ordinance, The Adjacent Owners shall deposit in the City Treasury of the. City of Chicago, a sum sufficient to defray the costs of removing paving and curb returns, and constructing sidewalk and curb at the entrance to that part of the alley hereby vacated, in accordance with current Department of Transportation's Regulations for Opening, Repair and Construction in the Public Way and its appendices.

SECTION 4. The vacation herein provided for is made upon the express condition that within. 180-days after the passage of this ordinance, The Adjacent Owners shall pay or cause to be paid to. the City of Chicago ascompensation.forthe benefits, which will accrue, to the owner of the property abutting said part of public alley hereby vacated the sum ^X1^/T)W*d h*,-rW) dollars (\$)u £ cG),

which sum in the judgment of this body will be equal to such benefits.

SECTION 5. The vacation herein provided for is made upon the express condition that within one hundred eighty (180) days after the passage of this ordinance, .The Adjacent Owners shall file or cause to be filed for record in the Office of the Recorder of Deeds of Cook County, Illinois a certified copy of this ordinance, together with thefull.sized associated plat, as approved by the Superintendent of Maps and Plats.

SECTION 6, This ordinance-shall take effect and be in force from and; after its: passage. The vacation shall take effect and be in force from and after its recording.
