ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all of the B1-1 Neighborhood Shopping District symbols and indications as shown on Map 5-H in the area bounded by:

the southerly line of the former C. M. St. P. & P. RR right-of-way; a line beginning at a point 309.42 feet east of North Leavitt Street as measured along the southerly line of the former C. M. St. P. & P. RR right-of-way extending to a point 36.15 feet south of and almost perpendicular to the southerly line of the former C. M. St. P. & P. RR right-of-way; a line beginning at last said point and extending 8.92 feet southwesterly to a point 303 feet east of North Leavitt Street as measured along the southerly line of the former C. M. St. P. & P. RR right-of-way; a line beginning at a point 41.85 feet south of the southerly line of the former C. M. St. P. & P. RR right-of-way extending 26.58 feet southwesterly to a point 275.91 feet east of North Leavitt Street; the vacated centerline of North Wilmot Avenue; North Wilmot Avenue; the public alley next southwesterly of and perpendicular to North Wilmot Avenue; a line beginning 71.58 feet southwest of the intersection of said public alley and North Wilmot Avenue as measured along the northwesterly line of said public alley and extending 25.00 feet to a point 185.70 feet south of the southerly line of the former C. M. St. P. & P. RR right-of-way; a line beginning at last said point and extending 143.70 feet to a point 42.00 feet south of the southerly line of the former C. M. St. P. & P. RR right-of-way; a line beginning at last said point and extending to the southerly line of the former C. M. St. P. & P. RR right-of-way;

to those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit Districts.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and publication .
