BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago zoning Ordinance be amended by changing all of the RS-3 Residential Single-Unit District symbols and indications as shown on Map No. 22-E in the area bound by:

a line 75 feet north of and parallel to East 95th Street; South Wabash Avenue, East 95th Street; and a line 75 feet west of and parallel to South Wabash Avenue.
