BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the POS-2, Public Open Space and Ml-2, Limited Manufacturing/ Business Park District symbols and indications as shown on Map No. 2-J in an area bound by

The south line of the Baltimore and Ohio Chicago Terminal Railroad right of way; the west boundary line of vacated South St. Louis Avenue extended; West Fillmore Street; South Central Park Avenue

to those of a Ml-2, Limited Manufacturing/ Business Park District.,
