### ORDINANCE

***filed / J ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.5-J in the area bounded by

the alley next north of and parallel to West Mclean Avenue; a line 224.75 feet west of and parallel to North Central Park Avenue; West Mclean Avenue; and a line 249.75 feet west of and parallel to North Central Park Avenue,

to those of a RM 4.5 Residential Multi-Unit District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.
