*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to CHICAGO'S HOME OF CHICKEN & WAFFLES, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, three (3) Awning (s) projecting over the public right-of-way adjacent to its premises known as 3947 S. Dr Martin Luther King Jr Dr..

Said Awning(s) at s. martin luther king jr dr. measure(s):

One (1) at six point one seven (6.17) feet in length, and two (2) feet in width for a total of twelve point three four (12.34) square feet.

Said Awning(s) at s. martin luther king jr dr. measure(s):

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1120305 herein granted the sum of one hundred fifty (\$150.00) per annum in advance.

A 25% penalty will be added for payments received after due date.
