ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The City Council finds that the areas described in Sections 2 and 3 of this ordinance are adversely affected by the over-concentration of businesses licensed to sell alcoholic liquor within and near the areas.

SECTION 2. Section 4-60-022 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-022(34.21) through 4-60-022(34.39), as follows:

4-60-022 Restrictions On Additional Licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional license shall be issued for the sale of alcoholic liquor, for consumption on the premises within the following areas:

- 21) <u>On Halsted Street, from 113th Street to 115th Street.</u>
- 22) On Halsted Street, from 117th Place to 118th Place.
- 23) <u>On Halsted Street, from 118th Place to 120th Street.</u>
- 24) <u>On Halsted Street, from 120th Street to 122nd Street.</u>
- 25) <u>On Halsted Street, from 122nd Street to 123rd Street thence on the east side only of Halsted Street, from 123rd Street to 124th Street.</u>
- 26) <u>On the east side only of Halsted Street, from 124th Street to 126th Street.</u>
- 27) On the east side only of Halsted Street, from 126th Street to 127th Street thence on both sides of Halsted Street, from 127th Street to Vermont Street.
- 28) On Halsted Street, from Vermont Street to the southern City Limit.
- 29) <u>On 115th Street, from Halsted Street to Union Avenue (north side of 115¹ Street).</u>
- 30) <u>On 115th Street, from Union Avenue (north side of 115th Street) to Wallace Street.</u>
- 31) <u>On 115th Street, from Wallace Street to Normal Avenue.</u>
- 32) <u>On 115th Street, from Normal Avenue to Stewart Avenue.</u>
- 33) <u>On 115th Street, from Stewart Avenue to Princeton Avenue.</u>

34)	On 115 th Street, from Princeton Avenue to Wentworth Avenue.
35)	On 115 th Street, from Wentworth Avenue to Perry Avenue.
36)	On 115 th Street, from Perry Avenue to State Street.
37)	Beginning at the intersection of 115 th Street and Halsted Avenue; thence west on 115 th Street to the railroad tracks: thence in a southeasterly direction along the railroad tracks to 117 th Place extended: thence east on 117 th Place extended to Halsted Avenue: thence north on Halsted Avenue to the place of beginning.
38)	On the north side only of 119 th Street, from State Street to Perry Avenue.
39)	On the north side only of 119 th Street, from Perry Avenue to Yale Avenue.

SECTION 3. Section 4-60-023 of the Municipal Code of Chicago is hereby amended by inserting the underscored language as new subsections 4-60-023(34.19) through 4-60-023(34.37), as follows:

4-60-023 Restrictions on additional package goods licenses.

Subject to the provisions of subsection 4-60-021 (c), no additional package goods license shall be issued for any premises located within the following areas:

20)	<u>On Halsted Street, from 117th Place to 118th Place.</u>
21)	On Halsted Street, from 118 th Place to 120 th Street.

23)	<u>On Halsted Street, from 122nd Street to 123rd Street thence on the east side only of Halsted Street, from 123rd Street to 124"¹ Street.</u>
24)	On the east side only of Halsted Street, from 124 th Street to 126 th Street.
25)	On the east side only of Halsted Street, from 126 th Street to 127 th Street thence on both sides of Halsted Street, from 127 th Street to Vermont Street.
26)	On Halsted Street, from Vermont Street to the southern City Limit.
27)	On 115 th Street, from Halsted Street to Union Avenue (north side of 115 th Street).
28)	On 115 th Street, from Union Avenue (north side of 115 th Street) to Wallace Street.

29) On 115 th Street, from Wallace Street to Norm	nal Avenue.

- 30) <u>On 115th Street, from Normal Avenue to Stewart Avenue.</u>
- 31) <u>On 115th Street, from Stewart Avenue to Princeton Avenue.</u>
- 32) <u>On 115th Street, from Princeton Avenue to Wentworth Avenue.</u>
- 33) <u>On 115th Street, from Wentworth Avenue to Perry Avenue.</u>
- 34) <u>On 115th Street, from Perry Avenue to State Street.</u>
- 35) Beginning at the intersection of 115th Street and Halsted Avenue: thence west on 115th Street to the railroad tracks: thence in a southeasterly direction along the railroad tracks to 117th Place extended: thence east on 117th Place extended to Halsted Avenue: thence north on Halsted Avenue to the place of beginning.
- 36) <u>On the north side only of 119th Street, from State Street to Perry Avenue.</u>
- 37) On the north side only of 119th Street, from Perry Avenue to Yale Avenue.

SECTION 4. This ordinance shall be in full force and effect from and after its passage and publication.
