ORDINANCE

WHEREAS, the City of Chicago (the "City") is a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois and as such may legislate as to matters which pertain to its local government and affairs; and

WHEREAS, the City Council of the City (the "City Council") has determined that the continuance of a shortage of rental housing affordable to persons of low and moderate income is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City programmed Multi-Unit Rehabilitation Assistance Program ("Multi-Program") funds whereby acquisition and rehabilitation loans were made available to owners of rental properties containing five or more dwelling units located in low- and moderate-income areas, and the Multi-Program is administered by

the City's Department of Planning and Development ("DPD"); and

WHEREAS, the City Council, pursuant to an ordinance enacted on September 16,1992, and published at pages 20584-20588 ofthe Journal ofthe Proceedings ofthe City Council (the "Journal of Proceedings") of that date, authorized DPD to provide Multi-Program financing in the aggregate amount of \$568,000 (the "Loan") for the acquisition and rehabilitation of a building (the "Building") located at 4156-60 West Madison Street/1-15 North Keeler Avenue, in Chicago, Illinois, which contains 6 commercial spaces and 18 residential dwelling units (the "Project"); and

WHEREAS, Foster Enterprises, Inc., an Illinois corporation (the "Borrower"), owns the Building; and

WHEREAS, in connection with the Project, the City made the Loan to the Borrower on December 30, 1992 with an interest rate of one percent per annum, which Loan is secured by, among other things, that certain Junior Mortgage and Security Agreement dated December 30,1992 and recorded on December 30,1992 in the Office of the Recorder of Deeds of Cook County, Illinois as document number 92985944, made by the Borrower in favor of the City (the "Mortgage"); and

WHEREAS, the Mortgage was subordinated to that certain mortgage dated as of December 30, 1992, securing a loan in the amount of \$466,236 (the "Original Senior Loan"), made by the Borrower in favor of Harris Trust and Savings Bank; and

WHEREAS, the Borrower has met with certain financial difficulties in the operation of the Building, and requested that DPD approve a proposed restructuring ofthe Loan; and

WHEREAS, in order to secure the long-term affordability of the Building, DPD has agreed to allow the Borrower to refinance and repay the Original Senior Loan and to receive the proceeds of a new loan from Community Investment Corporation, an Illinois not-for-profit corporation (the "New Senior Lender") in an amount not to exceed \$748,450 at a fixed interest rate not to exceed 4.75% per annum for a term not to exceed ten years (the "New Senior Financing"); and

WHEREAS, the New Senior Financing will be secured by a new mortgage made by the Borrower in favor of the New Senior Lender (the "New Senior Mortgage"); and

WHEREAS, DPD has approved a restructuring of the Loan (the "Restructuring") in a manner which (1) will not alter the principal amount of the Loan, (2) will not alter the interest rate on the principal balance of the Loan, (3) will not alter the maturity date of the Loan, (4) will alter the repayment terms of the Loan, (5) will defer certain delinquent payments, (6) will waive certain default interest and fees, and (7) will subordinate the Mortgage to any liens which will secure the New Senior Financing, including but not limited to the New Senior Mortgage (collectively, the "Material Terms"); now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Restructuring is hereby approved as described above. The Commissioner of DPD (the "Commissioner") or a designee of the Commissioner, are each hereby authorized, subject to approval by the Corporation Counsel, to negotiate any and all terms and provisions in connection with the Restructuring which do not substantially modify the Material Terms as described herein. The Commissioner, or a designee of the Commissioner, are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with the implementation of the Restructuring. The Commissioner or a designee of the Commissioner are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable, in connection with any future restructuring of the Loan, which do not substantially modify the Material Terms.

SECTION 3. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code of Chicago, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance. Section 2-45-110 of the Municipal Code of Chicago shall not apply to the Building in connection with the Restructuring.

SECTION 4. This ordinance shall be effective as of the date of its passage and approval.
