ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1.

Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 1-1 in the area bounded by:

A line 248.25 feet North of and almost parallel to West Grand Avenue (as measured along the West line of North Rockwell Street); North Rockwell Street; a line 223.25 feet North of and almost parallel to West Grand Avenue (as measured along the West line of North Rockwell Street); a public alley next West of and parallel to North Rockwell Street.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and approval. Common
