ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RT-4 Residential Two-Flat, Townhouse and Multi-Unit District symbols and indications as shown on Map Number 4-H in the area bounded by:

West 21st Street; South Wood Street; the public alley parallel to and south of West 21st Street; and a line parallel to and 58.00 feet west of the center line of the right of way of South Wood Street

to those of an RM-5 Residential Multi-Unit District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about October 22, 2015, the undersigned filed an application for a change in zoning from RT-4 Residential Two-Flat, Townhouse and Multi-Unit District to RM-5 Residential Multi-Unit District on behalf of the applicant/owner, Gemma Properties LLC, for the property located at 1801 W. 21st St.

The applicant intends to adapt former retail space on the first floor of an apartment building for residential purposes. The property is presently improved with two buildings - a main building containing three dwelling units and the former retail space presently occupied for dwelling purposes; and a coach house that was recently converted from two dwelling units to one dwelling unit. After the rezoning, there would be four legal dwelling units in the main building and one dwelling unit in the coach house.
