ORDINANCE

WHEREAS, the Annual Appropriation Ordinances for the years 2015 and 2016 of the City

of Chicago (the "City") contain estimates of revenues receivable as grants from agencies of the state and federal governments and public and private agencies; and

WHEREAS, in accordance with Section 8 of the Annual Appropriation Ordinances, the heads of various departments and agencies of the City have applied to agencies of the state and federal governments and public and private agencies for grants to the City for various purposes; and

WHEREAS, the City through its Department of Family and Support Services has been awarded federal grant funds in the amount of \$700,000 in fiscal year 2015 by the United States Department of Education; Office of Career, Technical, and Adult Education which shall be used in both the years 2015 and 2016 Performance Partnership Pilots for Disconnected Youth Program; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The sum of \$700,000 not previously appropriated, representing increased grant awards, is hereby appropriated from Fund 925 - Grant Funds for 2015 and carried over into 2016. The Annual Appropriation Ordinance for 2015 is hereby further amended by striking the words and figures and adding the words and figures indicated in the attached Exhibit A. SECTION 2. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.


SECTION 3. This ordinance shall be in full force and effect upon its passage and approval.
