SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.7-J in the area bounded by

The public alley next west and parallel to North Lawndale Avenue, a line 259.10 feet south of and parallel to West George Street, North Lawndale Avenue, a line 309.10 feet south of and parallel to West George Street

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District.
