ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the BI-2 Neighborhood Shopping District symbols and indications as shown on Map No. 9-H in the area bounded by

A perpendicular line to North Paulina Street 51.72 feet long starting at a point 270.90 feet north of the north line of West School Street (as measured along the east line of North Paulina Street); a northeasterly line 51.72 feet long perpendicular to North Lincoln Avenue starting at a point 270.09 feet north of the north line of West School Street and 51.75 feet east of the east line of North Paulina Street and ending at a point 329 feet northwest of the north line of West School Street (as measured along the southwest line of North Lincoln Avenue); North Lincoln Avenue; a southwesterly line 63.48 feet long perpendicular to North Lincoln Avenue starting at a point 279 feet northwest of West School Street (as measured along the southwest line of North Lincoln Avenue) and ending at a point 63.48 feet east of the east line of North Paulina Street and 220.90 feet north of the north line Of West School Street 9 as measured along the east line of North Paulina Street); North Paulina Street,

to those of a CI-2 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements of Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on March 16, 2016, Sara Sasha Harming (the "Applicant") will file an application for rezoning (the "Application"). The Applicant proposes to rezone the property commonly known 3328-3330 North Lincoln Avenue and 3325-3327 North Paulina Avenue (the "Property").

The Property has a lot size of approximately 5,764 square feet. The Property is currently improved with an existing 3-story building with commercial, retail space on the ground floor and residential dwelling units above grade. The Applicant proposes to seek City of Chicago approval to rezone the Property from BI-2, Neighborhood Shopping District to CI-2, Neighborhood Commercial District for the purpose of operating a massage and acupuncture business in approximately 1,200 square feet of commercial, retail space on the Property (the "Project").
