### ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of (he B3-5 Community Shopping District and RJv1-5 Residential Multi-Unit District symbols and indications as shown on Map No 3-F in the area bounded by:

A line 363.79 feet south of and parallel to West North Avenue; a line 102.25 feet west of and parallel to North Wells Street; a line 388.08 feet south of and parallel to West North Avenue; North Wells Street; a line 512.08 feet south of and parallel to West North Avenue; North Wieland Street

SECTION 2. To those of a B3-5 Community Shopping District;

Section 3: Changing all the B3-5 Community Shopping District symbols and indications shown on Map No. 3-F in the area bounded by:

A line 363.79 feet south of and parallel to West North Avenue; a line 102.25 feet west of and parallel to North Wells Street; a line 388.08 feet south of and parallel to West North Avenue; North Wells Street; a line 512.08 feet south of and parallel to West North Avenue; North Wieland Street

to those of a Residential Business Planned Development, and a corresponding use district, which is hereby established in the area above described

SECTION 3. This ordinance takes effect after its passage and due publication.

1. The area delineated herein as Planned Development Number \_\_\_\_\_, ("Planned .Development") consists of approximately 28,072 square feet of property which is depicted on the attached Planned Development Boundary and Property Line Map ("Property") and is owned or controlled by the Applicant, Wellstel, LLC.
2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors. All rights granted hereunder to the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Property, at the time of application for amendments, modifications or changes (administrative, legislative or otherwise) to this Planned Development are made, shall be under single ownership or designated control. Single designated control is defined in Section 17-8-0400 of the Zoning Ordinance.
3. All applicable official reviews, approvals or permits are required to be obtained by the Applicant or its

successors, assignees or grantees. Any dedication or vacation of streets or alleys or grants of easements or any adjustment of the right-of-way shall require a separate submittal to the Department of Transportation on behalf of the Applicant or its successors, assigns or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with the Plans.

Ingress or egress shall be pursuant to the Plans and may be subject to the review and approval of the Departments of Planning and Development and Transportation. Closure of all or any public street or alley during demolition or construction shall be subject to the review and approval of the Department of Transportation.

All work proposed in the public way must be designed and constructed in accordance with the Department of Transportation Construction Standards for Work in the Public Way and in compliance with the Municipal Code of the City of Chicago. Prior to the issuance of any Part II approval, the submitted plans must be approved by the Department of Transportation.

4. This Plan of Development consists of 16 Statements: a Bulk Regulations Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary Map, Sub Area and Property Line Map; Site Plan Landscape/Green Roof Plan; Building Elevations (North, South, East and West) prepared by Pappageorge Haymes. Partners and dated June 16, 2016, submitted herein. Full-sized copies of the Site Plan, Landscape Plan and Building Elevations are on file with the Department of Planning and Development. provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the terms of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.

5. The following uses are permitted in the area delineated herein as a Planned Development:

Sub Area A: hotel, retail, eating and drinking establishments, outdoor patios (rooftop); banquet and meeting rooms, commercial, office and accessory uses;

Sub Area B: single family detached homes and accessory uses (at grade); Prior to the issuance of any Part II approval for this subarea, final design elevations for the single family homes must be reviewed and approved by the Department of Planning and Development.

Sub Area C: retail and residential uses (above the ground floor) and accessory uses.

Sub Area D: accessory parking for Sub Area A and B; loading areas; parking and loading ramps; and accessory uses. In accordance with Section 17-10-0503 of the Municipal Code, the Applicant may lease to members of the public on a daily, weekly or monthly basis up to twenty-five percent (25%) of the minimum required parking spaces

6. On-Premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Planning and Development. Off-Premise signs are prohibited within the boundary of the Planned Development.
7. For purposes of height measurement, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations, if any, established by the Federal Aviation Administration.
8. The maximum permitted Floor Area Ratio ("FAR") for the site shall be in accordance with the attached Bulk Regulations Table. For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR identified in the Bulk Regulations Table has been determined using a Net Site Area of 28,072 square feet.
9. Upon review and determination, "Part II Review", pursuant to Section 17-13-0610 of the Zoning Ordinance, a Part II Review Fee shall be assessed by the Department of Planning and Development. The fee, as determined by staff at the time, is final and binding on the Applicant and must be paid to the Department of Revenue prior to the issuance of any Part II approval.

10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any other corresponding regulations and guidelines. Final landscape plan review and approval will be by the Department of Planning and Development. Any interim reviews associated with site plan review or Part II reviews, are conditional until final Part II approval.
11. The Applicant shall comply with Rules and Regulations for the Maintenance of Stockpiles promulgated by the Commissioners of the Departments of Streets and Sanitation, Fleet and Facility Management and Buildings, under Section 13-32-125 of the Municipal Code, or any other provision of that Code.
12. The terms and conditions of development under this Planned Development ordinance may be modified administratively, pursuant to section 17-13-061 1-A of the Zoning Ordinance by the Zoning Administrator upon the application for such a modification by the Applicant, its successors and assigns and, if different than the Applicant, the legal title holders and any ground lessors.

13. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Property. Plans for all buildings and improvements on the Property shall be reviewed and approved by the Mayor's Office for People with Disabilities to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.
14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs, conserves energy and maximizes the preservation of natural resources. At the time of a hearing before the Chicago Plan Commission, all developments must be in substantial compliance with the current City of Chicago Sustainable Development Policy set forth by the Department of Planning and Development. In Sub Area A, the Applicant shall provide a green roof for a minimum of 50% of the net roof area, or 3,927 square feet. In addition, the building in Sub Area A shall achieve building certification consistent with the City of Chicago Sustainable Development Policy.
15. Applicant and the Department of Planning and Development, at either party's request, may continue to evolve the design of the building elevations in Sub Area A and changes to such elevations, if any, shall, if mutually agreed, be approved by the Department of Planning and Development administratively as a Minor Change as set forth in Section 17-13-0611 of the Chicago Zoning Ordinance.
16. This Planned Development shall be governed by Section 17-13-0612 of the Zoning Ordinance. Should this Planned Development ordinance lapse, the Commissioner of the  
. Department of Planning and Development shall initiate a Zoning Map Amendment to rezone the property to B3-5 Community Shopping District.

Pursuant to the provisions of the Chicago Zoning Ordinance, Title 17 of the Municipal Code of Chicago, the Department of Planning and Development hereby submit this report and recommendation on a proposed Business Planned Development for your review and recommendation to the Chicago City Council. The application for the amendment to the Chicago Zoning Ordinance was introduced into the City Council on March 16, 2016. Proper legal notice of the public hearing on the application was published in the Chicago Sun Times on June 1, 2016. The Applicant was separately notified of this hearing.

This application is submitted as a mandatory planned development pursuant to section 17-8-0512-B (Tall Buildings) which requires planned development review and approval for any building in a B3-5 Zoning District that meets or exceeds 80 feet.

**SITE AND AREA DESCRIPTION**

1. Planned Development Boundary Map 2. Existing Zoning Map

The project consists of three rectangular shaped lots containing a total of 28,073 square feet and is bounded on the north by an existing 2-story commercial building, on the east by North Wells Street, on the south by an existing 2-story masonry

building and on the west by North Wieland Avenue.

#### **PROJECT DESCRIPTION AND BUILDING DESIGN**

The applicant proposes to rezone the site from B3-5 (Community Shopping District) and RM-5 (Residential Multi-Unit District) to B3-5 (Community Shopping District) prior to establishing the Residential Business Planned Development. The proposal will establish four (4) subareas, to allow the development of a 12-story hotel + mechanical roof top level with ground floor retail, four single family homes and accessory parking and related uses.

#### **4. Rendering: North Wells Street 5. Rendering: North Wieland Avenue**

#### **ACCESS/CIRCULATION**

The existing condition of the site includes two curb cuts and as part of this development the curb cut along North Wieland will be removed and the existing North Wells Street curb cut will be improved. The proposal will allow access for vehicular traffic via the new curb cut along North Wells Street and will leads to an accessory parking level below grade. The parking level contains the fifty-three (53) accessory parking spaces for the entire planned development. Loading will occur internal to the site and is provided by a 10'x 25' loading berth/space located along the entrance ramp of the hotel building. Access for pedestrians to the hotel and restaurant occurs through a hotel entry lobby located along North Wells Street.

#### **LANDSCAPING and SUSTAINABILITY**

The applicant must comply with the City of Chicago's Landscape Ordinance. The developer will provide landscaping options to the single family homes in Subarea B and the final designs are subject to the review of

the Department of Planning and Development. In addition the proposed building in Subarea A is required to achieve LEED certification and provide a 50% green roof as defined by the City of Chicago Sustainable Guidelines.

### **BULK/USE/DENSITY**

Reference attached Bulk and Data Table Exhibit.

### **RECOMMENDATION**

The Department of Planning and Development has reviewed the project materials submitted by the Applicant and have concluded that the proposed development would be appropriate for the site for the following reasons:

The project complies with the Standards and Guidelines for Planned Developments in the Zoning Ordinance (Section 17-8-0900).

1. 17-3-0400 Bulk and Density standards. The proposed Planned Development would not increase the maximum Floor Area Ratio (F.A.R.) stipulated under the B3-5 District but would be restricted to an overall 5.0 FAR and will be consistent with the surrounding area. This project will have similar uses as the surrounding areas, which include commercial and retail uses, and accessory parking spaces.
2. 17-8-0908 Green Design: The proposed hotel building shall be required to achieve LEED certification and provide a 50% Green Roof over the net roof area of the hotel building in Subarea A to satisfy the requirements of the City of Chicago's Sustainable Guidelines.
3. 17-8-0905 Pedestrian Orientation: Primary pedestrian entrances for the hotel building are located at the sidewalk level and allow unimpeded pedestrian flow along North Wells Street. Furthermore the entire street frontage of the building along North Wells Street is enlivened by an architectural storefront system looking directly onto the street frontage.
4. 17-8-0904 Transportation, Traffic, Circulation and Parking: Motor vehicle parking would be accessed from North Wells Street and loading will occur internal to the site via a loading berth located at the basement level entrance ramp. The existing conditions will be improved by eliminating the existing curb cut along North Wieland Avenue and relocating and improving the North Wells Street curb cut.

5. 17-8-0901 Use, Bulk, Density and Intensity: The proposed development is compatible with the character of the surrounding area in terms of uses and density. The proposed Planned Development would be consistent in bulk, density, and Floor Area Ratio (F.A.R.) with the surrounding area. The proposed project will be limited to a maximum Floor Area Ratio (F.A.R.) to 5.0. The height of the proposed 12-story (151'-4") hotel building will be consistent with, and is within the context of the overall surrounding area.

Based on the foregoing, it is the recommendation of the Department of Planning and Development that the revised application submitted by Wellstel, LLC for a Residential Business Planned Development be approved and that the recommendation to the City Council Committee on Zoning, Landmarks and Building Standards is: "As Amended, Passage Recommended."
