BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 3-1 in the area bounded by

A line 50 feet north of and parallel to West Lemoyne Street; A line 125 feet east of and parallel to North Fairfield Avenue; West Lemoyne Street; North Fairfield Avenue

to those of a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District SECTION 2.

This ordinance takes effect after its passage and approval.




