ORDINANCE WINTRUST  
BANK Acct. No. 289005 - 7  
Permit No. 1121908

*Be It Ordained by the City Council of the City of Chicago:*

SECTION 1. Permission and authority are hereby given and granted to WINTRUST BANK, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use four (4) Awning(s) projecting over the public right-of-way adjacent to its premises known as 1800 S. Blue Island Ave..

Said Awning(s) at S. Blue Island Avenue measure(s):

One (1) at ten point six seven (10.67) feet in length, and three (3) feet in width for a total of thirty-two pointzero one (32.01) square feet.

One (1) at fifteen point five eight (15.58) feet in length, and three (3) feet in width for a total of forty-six point seven four (46.74) square feet.

One (1) at eleven point nine two (11.92) feet in length, and three (3) feet in width for a total of thirty-five point seven six (35.76) square feet.

One (1) at fourteen point five (14.5) feet in length, and three (3) feet in width for a total of forty-three point five (43.5) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1121908 herein granted the sum of seventy-five (\$75.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
