ORDINANCE KAZIMIERZ
KROL Acct. No. 354169 - 1
Permit No. 1121594

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to KAZIMIERZ KROL, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, one (1) Occupation of Space(s) on the public right-of-way adjacent to its premises known as 7500 W. Bryn Mawr.

Said Occupation of Space(s) at W. Bryn Mawr measure(s):

One (1) atone hundred sixty-five point three (165.3) in length, and seventeen point eight three (17.83) feet in width for a total of two thousand nine hundred forty-seven point two nine (2,947.29) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development, Department of Transportation (Division of Project Development), and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1121594 herein granted the sum of two thousand five hundred twenty-five (\$2,525.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
