BE IT ORDAINED BY THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols and indicators as shown on Map No. 7-K in the area bounded by

The public alley next north of and parallel to West Fullerton Avenue; a line 83.45 feet east of and parallel to North Kildare Avenue; West Fullerton Avenue; and a line 133.45 feet east of and parallel to North Kildare Avenue.

to those of a C1-1 Neighborhood Commercial District.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about April 7, 2016, the undersigned will file an application for a change in zoning from B1-1 Neighborhood Shopping District to C1-1 Neighborhood Commercial District on behalf of Nodarse Holdings, Inc. for the property located at 4246 West Fullerton Avenue, Chicago, IL 60639.

The applicant intends to use the subject property to open a "La Caridad" Jewelry and Loan Store in the commercial unit of the current structure.
