ORDINANCE IRAZU INC
Acct. No. 23764 - 2 Permit
No. 1121879

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to IRAZU INC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use six (6) Window & Frame(s) projecting over the public right-of-way adjacent to its premises known as 1865 N. Milwaukee Ave..

Said Window & Frame(s) at N Milwaukee Ave measure(s):

One (1) at ten point five (10.5) feet in length, and three (3) feet in width for a total of thirty-one point five (31.5) square feet.

One (1) at seven (7) feet in length, and three (3) feet in width for a total of twenty-one (21) square feet.

One (1) at seventeen point four two (17.42) feet in length, and three (3) feet in width for a total of fifty-two point two six (52.26) square feet.

One (1) at nine point zero eight (9.08) feet in length, and three (3) feet in width for a total of twenty-seven point two four (27.24) square feet.

Said Window & Frame(s) at N Oakley Ave measure(s):

One (1) at thirteen point five eight (13.58) feet in length, and three (3) feet in width for a total of forty point seven four (40.74) square feet.

One (1) at eighteen point eight three (18.83) feet in length, and three (3) feet in width for a total of fifty-six point four nine (56.49) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Division of Project Development).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1121879 herein granted the sum of two thousand four hundred (\$2,400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.

Authority herein given and granted for a period of five (5) years from and after Date of Passage.
