

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1 That the City Zoning Ordinance by amended by changing all the Bl-3 Neighborhood Shopping District symbols and indications as shown on Map No. 6-G in area bound by

WEST FULLER STREET; A LINE 128.45 FEET IN LENGTH COMMENCING AT A 139.80 FEET SOUTHWEST OF THE INTERSECTION OF WEST FULLER STREET AND SOUTH ARCHER AVENUE; SOUTH ARCHER AVENUE; A LINE 151.18 AT **FEET** IN **LENGTH COMMENCING POINT** 164.80 FEET **SOUTHWEST** OF THE INTERSECTION **OF** WEST **FULLER** STREET **AND** SOUTH ARCHER AVENUE

To those of a B2-3 Neighborhood Mixed-Use District, and a corresponding use district is hereby established in the area above described.

SECTION 2 The ordinance shall be in force and effect from and after its passage and due publication.


