BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHICAGO;

SECTION 1. Section 1 Title 17 of the Municipal Code of Chicago, The Chicago Zoning Ordinance, is HEREBY amended by changing all the RS3 Residential Single Unit (detached house) District symbols and indications as shown on Map < 6-G in an area bounded by:

BEGINNING AT THE NORTHEAST CORNER OF THE NORTHEAST LINE OF THE 16-FOOT PUBLIC ALLEY; THENCE NORTHEASTERLY A DISTANCE OF 48.00 FEET TO A POINT; THENCE SOUTHEASTERLY A DISTANCE OF 100.00 FEET TO A POINT; THENCE SOUTHWESTERLY A DISTANCE OF 45.00 FEET TO A POINT; THENCE NORTHWESTERLY A DISTANCE OF 4.26 FEET TO A POINT; THENCE NORTHWESTERLY A DISTANCE OF 97.00 FEET TO THE POINT OF BEGINNING.
