ORDINANCE TRADER JOE'S Acct. No. 211718-5 Permit No. 1123139

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to TRADER JOE'S, upon the terms and subject to the conditions of this ordinance to maintain and use, as now constructed, eight (8) Awning(s) projecting over the public right-of-way adjacent to its premises known as 667 W. Diversey Pkwy..

Said Awning(s) at W. Diversey Parkway measure(s):

One (1) at seventeen point four two (17.42) feet in length, and two point eight three (2.83) feet in width for a total of fortynine point three (49.3) square feet.

One (1) at ten point seven five (10.75) feet in length, and two point eight three (2.83) feet in width for a total of thirty point four two (30.42) square feet.

One (1) at sixteen point three three (16.33) feet in length, and two point eight three (2.83) feet in width for a total of fortysix point two one (46.21) square feet.

One (1) at thirteen point two five (13.25) feet in length, and two point eight three (2.83) feet in width for a total of thirty-seven point five (37.5) square feet.

One (1) at thirteen point five eight (13.58) feet in length, and two point eight three (2.83) feet in width for a total of thirtyeight point four three (38.43) square feet.

One (1) at thirteen point nine two (13.92) feet in length, and two point eight three (2.83) feet in width for a total of thirtynine point three nine (39.39) square feet.

One (1) at ten point one seven (10.17) feet in length, and two point eight three (2.83) feet in width for a total of twentyeight point seven eight (28.78) square feet.

One (1) at fifteen point seven five (15.75) feet in length, and two point eight three (2.83) feet in width for a total of fortyfour point five seven (44.57) square feet.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1123139 herein granted the sum of one hundred seventy-five (\$175.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.
