TRAFFIC LANE - TOW ZONES

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Pursuant to Title 9, Chapter 64, of the Municipal Code of Chicago, the following locations are hereby designated as Traffic Lane - Tow Zones, between the limits and during the times specified, standing or parking of any vehicle shall be considered a definite hazard to the normal movement of traffic:

41	6548-6542 West Hurlbut Street; West Hurlbut Street (north side) from North Northcott Avenue to a point 234 feet west thereof; No Parking Tow Zone, 7:00am to 10:00am and 2:00pm to 4:00pm, School Days - (16-02131261) [Or2016-84]
42 East On	tario Street; East Ontario Street (south side) from a point 170 feet east of North Fairbanks Street to North McClurg Court; No Parking Tow Zone, 4:00pm to 6:00pm, Monday through Friday - (15-03298586) [02015-5200]
50	North California Avenue; North California Avenue (east side) from a point 27 feet north of West Rosemont Avenue to a point 80 feet north thereof; No Parking Tow Zone, 8:00am to 4:30pm, Sunday through Friday - (16-02287622) [02016-3331]
