# **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols as shown on Map No. 12-H in the area bounded by:

A line 312 feet North of and parallel to West 49<sup>th</sup> Street; South Hermitage Avenue; a line 288 feet North of and parallel to West 49<sup>th</sup> Street; the public alley next West of and parallel to South Hermitage Avenue.

To those of an RM4.5, Residential Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication. Common
